

In accordance with the Federal Law on Protection of Personal Data Held by Private Parties, we report the following:

Parque Industrial Querétaro informs you of the privacy policy and data management personal, in which at all times it will seek that the treatment thereof is legitimate, controlled and informed, in order to ensure privacy, confidentiality, integrity and the right to informative self-determination of your data.

In the collection and processing of said information, **Parque Industrial Querétaro** will commits and obliges to observe and comply with the principles of legality, consent, information, quality, purpose, loyalty, proportionality and responsibility. This is, to everyone the data that we request is collected in a lawful manner in accordance with the Federal Protection Law of Data Held by Private Parties, with your consent, collecting only and exclusively the data, pertinent, correct, updated and necessary for the sole purpose of comply with providing a service.

Parque Industrial Querétaro only obtains the personal data of its owners, either because it is has a legal relationship with said owner or, there is the possibility of having such a relationship legal, directly and personally, or through electronic, optical, sound, visual or by any other technology or other sources that are permitted by law, in order to prove the identification of the owner of said personal data in accordance with with the applicable laws and provisions and with the sole purpose of being able to enter into the contract that, if applicable and by mutual agreement, is intended to be formalized, to maintain and guard the file and the respective information.

For the aforementioned reasons, **Parque Industrial Querétaro** may collect data from identification such as name, surname, address, email, landline, mobile phone, Company name, contact position, company website, tax information such as address tax and Federal Taxpayer Registry number, as well as financial data such as bank account information and credit and / or debit card information and forms of payment.

Your personal data will never be disclosed or shared with third parties (there will be no transfer of data), nor will they be given a use other than that contracted, unless there is a change in this notice Of privacy. Likewise, **Parque Industrial Querétaro** may use the information of the holders of personal data to contact them, collect information and any act related to the needs of the owners and of the Querétaro Industrial Park.

Parque Industrial Querétaro will use the email provided to send emails direct mailings (hereinafter mailings) in order to follow up on requests, suggestions, claims and / or any other request of the Holder. In the same way, mailings will be sent to carry out technical updates of the products or services that you have acquired, as well as to maintain and monitor them. Likewise, mailings can be sent to let you know about promotions, offer our products or services, take any action commercial, marketing, statistical and prospecting on a daily, weekly and / or frequency monthly.

The Holder may revoke the consent to receive communications at any time by mailing through the tools that we put at your disposal in the emails emails sent (unsubscribe link at the end of messages)

In case the users holding personal data want to exercise the ARCO rights (access, cancellation, rectification and opposition to the processing of your personal data), they must do by sending your



request directly to the Personal Data Attention area through the Email account: informacion@pig.com.mx.

Said request must contain at least:

- (a) name and address or other means to communicate the response to your request.
- (b) the documents that prove your identity or, where appropriate, the legal representation.
- (c) the clear and precise description of the personal data with respect to which it is requested to exercise any of the ARCO rights.
- (d) any other element that facilitates the location of personal data.

In terms of the Law, you may submit a request to us to exercise your ARCO rights; Y within 15 days from the date on which **Parque Industrial Querétaro** responds to your request or, if after the term established by the Law, **Parque Industrial Querétaro** does not give response to your request, then you can start the procedure for the protection of ARCO rights before the Federal Institute for Access to Information and Protection of Personal Data (IFAI).

Parque Industrial Querétaro reserves the right to modify or update this notice of privacy at any time, for the attention, adaptation and compliance of the legal modifications, which may be applicable, internal policies or new requirements for the provision or offering of our services or products, and will keep it always available through this channel for your consultation.
